# The minutes below detail the OAGS AGM of the 15<sup>th</sup> of December 2012

#### ANNUAL GENERAL MEETING OF THE OAGS

## 1. WELCOME AND CONFIRMATION OF AGENDA

The Chairman, Mr. Bitam, welcomed all delegates present and outlined the agenda and how it will progress throughout the meeting. The agenda was accepted by official OAGS Members namely Niger, Algeria, Senegal and South Africa whilst observers acknowledged the agenda.

## 2. MINUTES OF THE PREVIOUS MEETING

Mr. L Bitam delivered a presentation detailing the meeting of the OAGS which was held in Windhoek, Namibia in 2012. Additionally, the participation of him at the EGS meeting in Brussels in March 2012, the participation of Mr. A Hassan at the EGS meeting in Brussels in January 2012 and the participation of Mr. Duodu at the AU meeting in Addis Abeba in November 2012. In his report Mr. A Hassan stated that the conference was high level and the theme was on "EU partnerships on raw materials" and was on launching commodities in future between EU and Africa. The conference had three categories;

- Good Governance
- 2. Infrastructure Development
- 3. Transparency

He stated also that the EU is willing to cooperate with that AU and that there's a possibility of enforcing exploration in Africa and participation. Whilst Mr. L Bitam highlighted that at the meeting he attended the EU Commission listed six priorities.

# 3. ANNUAL REPORT ON OAGS PROJECTS

Copies of presentations made were presented to participants as a bound document, and will be made available on the website.

# 3.1. Role of Geological Surveys in Supporting Small-Scale Mining (SSM) - Ghana and Nigeria

A detailed report from Ghana and Niger was presented at the meeting and Mr. Duodu's presentation viewed by all. The participants noted that OAGs was never invited officially to the meeting that Mr. Duodu attended and presented issues on OAGS. The report was acknowledged.

Resolution: In future it will be better if any invitations to any event should get authority of the Secretariat and or President.

## 3.2. Atlas of African Geosites

The Geological Survey of Namibia in Windhoek accepted the models; the President will have a communications with Mr. Tafer regarding the participation of Algeria. South Africa stated that is working on its contribution on Geosites.

Resolution: Algeria will publish the first volume supported by South Africa

# 3.3. Seismotectonic Map of Africa – M Al Gabry Egypt

An agreement on the frame of these projects proposed for the first draft was adopted. Participants also discussed funding opportunities for these projects.

## Resolution: 1. OAGS to write a letter to Prof Meghraoui

- 2. Algeria to print the map
- 3. Ask Ghana to support the geoteam's stay in Accra and write an invitation letter for them.
- 4. Request a meeting in Ghana in 2013

Senegal, Niger, South Africa and Algeria supported the proposal

## 3.4. Seismotectonic Map of Maghreb Region - A Ayadi, Algeria

Part of the African Map will not be adopted as the presentation is only to inform members about how the work is going. The map is ready.

3.5. Seismotectonic map of Algeria – S Guellai Algeria

Resolution: Acknowledge the progress of the map and congratulate the authors

## 3.6. Seismotectonic map of other African regions

# 3.7. OAGS Bulletin - Algeria

Mr. L Bitam noted that the issue of poor communication has been noted in previous meetings, explaining that this has now impacted the production of the second bulletin of the activities of the OAGS. He was supported by Mr. L Demichelli of the EuroGeosurveys in underscoring the importance of this bulletin for the OAGS. The bulletin was unfortunately not printed unfortunately as the members are not submitting contributions

## **Resolution:**

- 1. Proposed an electronic version to be coordinated by the Secretariat and Presidency and should focus on the meeting that took place in Niamey and to include all presentations.
- 2. Secretariat to circulate to all members
- 3. Algeria to print hard copies as well and distribute

# 4. FINAL DOCUMENT ON COOPERATION OAGS -EGS (Bitam and Demichelli)

The joint signing of the memorandum of cooperation was done at Palais de Congres, on 12 Decme3ber 2012 witnessed by participants and acknowledged.

Resolution: circulate to other countries for comments to be received by end of February 2013

## 5. NEW PROJECTS AND ACTIONS PROGRAM FOR 2013

Participants agreed to consider and concentrate only on three of the five projects currently run by OAGS member countries.

# 6. 35<sup>TH</sup> INTERNATIONAL GEOLOGICAL CONGRESS PRESENTATION – Mr. F Ramagwede South Africa

A presentation outlining the bid South Africa submitted on behalf of Africa to host the 35<sup>th</sup> IGC in 2016, the subsequent handover ceremony which took place in Brisbane this year and the role Africa geological surveys are encouraged to paly was outlined.

Resolution: - 1. Consider adding the OAGS logo on all marketing material

- 2. An African Pavilion to be proposed to the 35<sup>th</sup> IGC LOC.
- 3. OAGs members to propose sites to be visited in their countries for excursions

## 7. DISCUSSION ABOUT OAGS PROBLEMS

7.1 SECRETARIAT

Since the departure of Chantelle Ashley there's not replacement. Mr. Ramagwede told members that Ms N Mdluli Jacha is Acting Secretary in the meantime until he finds a replacement.
